# LAW BREAKING RESIDENT BULLDOZES DUNES FOR A BETTER VIEW



Perhaps out of frustration, perhaps just out of sheer disregard for the environment and her neighbours, but whatever prompted a beachfront homeowner to bulldoze the dunes in front of her house, is likely to result in severe penalties and probably a court case.

And to make matters worse, when confronted at 'the scene of the crime' while the bulldozer was busy with its destruction, she told the relevant Ratepavers representatives that she had permission to carry this out. After much insistence on providing proof it turns out this was a blatant lie. And this from a lady who has connections to a business which markets internationally and who is certainly aware of what is and isn't acceptable globally as far as being ecologically

sensitive goes.

The on-going saga of dune encroachment onto the properties of the unlucky homeowners whose properties face the beach has resulted in many, many meetings, discussions with the authorities and pleas to the Ratepayers Association and the matter looks no closer to resolution. Of course, houses built in a dune zone were always going to be at risk. By their very nature, dunes are wind driven, evermoving objects and approval should never have been given, way back then, for houses to be built in these fragile, unstable areas. But surely, purchasing or building a home in such an unstable environment should have raised alarm bells?

Approximately 1500 people attended the event, which hosted the TruCape Kogelberg Mountain Challenge. Sixty stalls, a busy food and wine area, excellent entertain-ment by Fraser, as well as a spitbraai kept everyone entertained. The concept for the 2010 festival was a conservancy related event, with several regional nurseries and landscapers exhibiting and selling their goods, which also included other garden related items such as pots, paving and compost.

# LAW BREAKING RESIDENT BULLDOZES DUNES FOR A BETTER VIEW CONTINUED...



One can understand a certain frustration but taking the law into their own hands, disregarding entirely the values of the community at large, resorting to a bulldozer lopping off the top of the dunes for a better view while driving over very sensitive dunes in a biosphere, is surely a very serious act of vandalism and destruction.

And is it true that a local earth-moving company, who has generated a lot of business from this village over the years, carried out the deed and seemed to have made no special effort to see written permission before carrying out what is obviously a very ecological provocative act? If so, it is very disappointing. It's just not

good enough to say " I was only doing what I was told'!

In the long term perhaps wind diversion (as done effectively in Namibia), the construction of Gabion Basket walls, or planting of specific grasses which hold the dunes together, will provide the solution. In the meantime, many residents of Pringle Bay are quite entitled to be exceedingly angry and unhappy with this blatant disregard for the environment and all who live in it.

The general consensus is that the matter must not, at any cost, be allowed to rest. If you have a view on this, write to the editor with your thoughts and views.

# WHY IS THE SECURITY CAMERA PROJECT TAKING SO LONG?

We all spoke very enthusiastically at the inaugural meeting, and yet somehow, we don't see a lot happening?

The Security Committee can report that although not a lot of progress is evident to the average Pringle Bayer, the project is moving along and a great deal of behind-thescenes activity is taking place to process the approval of plans for our small structure at the village entrance.

Initially it was thought that this would be a mere formality but the process was held up by some legal technicalities.

However, the Ratepayers Association have now just been informed again that the Municipality, who has been very supportive throughout, will be holding their necessary 'approval meeting' in late January and so hopefully, work can start on the construction of the building in February.

But a major stumbling block is the surprising lack of funds. Initially a lot of verbal commitments were made regarding the raising of the approximately R180,000 required and although the smaller contributors have been wonderful with the donations and pledges that have been made, it is disappointing to note that those individuals and organizations that are in a position to make substantial donations, have not yet done so. Various efforts are being made to continue to solicit donations and a very successful function was held in the Community Hall which raised approximately R30,000 for this very worthwhile project.

So, all being well, the next Pringle Post will be able to report on 'the start of building of the Security Camera project'!

# PRINGLE BAY RATEPAYERS' ASSOCIATION **CHAIRPERSON'S REPORT - 2010**

#### INTRODUCTION

This is an appropriate moment to report on the activities of the Pringle Bay Ratepayers' Association (PBRA) over the past year and to thank you all for your continued support and interest. One of the highlights this year was the way in which the PBRA, the Chamber of Commerce, the Ladies' Club, Conservancy, Fire Wise, the Boat Club, and the Community Hall committees all worked together to the benefit of this beautiful and serene village.

2010 was a very busy year with many issues and events and my sincere thanks to the Executive Committee (EXCO) members for all their hard work and dedication.

Every committee member is responsible for one portfolio. The committee's success this year is attributed to the interest and dedication of each member.

The aim of the PBRA is to protect the rights and interests of all residents and homeowners of Pringle Bay and to negotiate and liaise with the relevant local authority. The Executive Committee has made a special effort to work effectively with the Overstrand Municipality this year and to assist in conveying the ratepayers' views and needs to them.

The Pringle Bay Ratepayers' Association is grateful for the service and attention of the Municipality – many thanks to the Area Manager, Cecile Jonkheid and her staff.

An EXCO member attends all monthly Sub-council Meetings, and we are represented at meetings of the Police Forum, Fire Wise, and other bodies. We liaise with the Ratepayers' Associations in Betty's Bay, Rooi Els and Kleinmond.

Other very important activities relate to the Ward Forums. Our contributions include the presentation of our budget, as it pertains to our needs, to the Annual Overstrand Budget Committee, as well as to monitoring progress on expenditure during the year. We also discuss and comment on proposed new by-laws.

# **PORTFOLIOS**

The following are summaries of the most important aspects addressed by the Portfolio Managers in their reports:

#### 1.1 Security - Axel Maier -

The range of this portfolio is very extensive. It covers burglaries, poaching, vagrancy, petty crime, wilful damage to property, more or less anything, etc. The demands on time are inestimable and undiscriminating. As much as possible, this agency attempts to cover whatever difficult situations may arise, but there are limits to the influence and time of one individual in a growing community like Pringle Bay. This must be

Overstrand Municipality understood and handled with sensitivity.

On the positive side, there has been a noticeable reduction in the number of break-ins this year, thanks to the quick response of our local Security firm and this department, and hopefully with the installation of the Security Camera shortly, this will continue. However, there is still a serious call for homeowners to alarm their properties to avoid Pringle Bay being earmarked as a 'soft target'. This is a very real danger and source of concern. Please urge those not committed to do so asap. It will also take some of the pressure off this portfolio. Poaching continues to be a major activity on our plentiful but rapidly depleting waters, and the limitations of the squad equipped to cope with this is also quite alarming. The need for vigilance by all members of our community is more important now than ever.:

# 1.2 Membership - Graham Utton -

Membership is now paid up for over 300 members - the result of attaching membership forms to the security camera appeal through email and mailbox drop. It is hoped that the canvassing for Community Watch participation will encourage additional membership.

Our database of members has successfully been merged with the municipal property valuation role and crosschecked with the list supplied be the Security Subcommittee. Data is updated and checked with responses from membership updates and rejects received from the various mailing and SMS campaigns. An invaluable resource will be information collected by zone managers of the Community Watch.

## 1.3 Web Site - Graham Utton -

Ronel Theron was appointed as webmaster.

The list of 'useful numbers' has been updated to include portfolio responsibilities and email addresses @pringlebayratepayers.co.za, which are automatically redirected to the related personal email addresses. We now have mailboxes for the chairperson, secretary, treasurer, info, editor, baboon watch, roads, security, conservancy, property, policing, fire, community hall, community watch, commerce and legal.

Membership and nomination forms have been updated to reflect current postal and committee information.

The guide for residents has been reloaded.

Pages for Baboon Watch and Community Watch have been created and a page for Conservancy will follow when material becomes available.

A page will be shortly be created for the Community Hall, describing the facility, the hire conditions and an indication of the costs. Draft material has been received.

An announcement page has been created which currently features the images of the Hall construction.

The Image Gallery is operational and includes an invitation to members to submit images for possible display. The 'get in touch' links are also operational.

The lobster section is currently blank but will shortly display the recently announced permit costs. Details of the season dates and catch times will be displayed when they are announced.

Provision has been made for Pringle Post Monthly and contributions will be uploaded when available. If contributors do not heed the urgency of contributions, much of the current topical impact of this important newspaper will be lost.:

#### 1.4 Roads - Roux Kritzinger -

Potholes in tarred roads were fixed promptly and with the exception of the 5-way stop Page 4 PRINGLE POST

in the Central Business
District (CBD), all requests
were completed. The load
restriction signs were erected
in Central and Peak Roads. A
Stop sign was also recently
erected at the junction of
Peak and Diagonal Roads,
making a dangerous crossing
relatively safe. Several speed
hump signs and stop signs
were pushed or driven over
and were repaired as soon as
reported.

Gravel roads were graded and resurfaced in spite of difficulties in getting a suitable grader driver.

# <u>1.5 Stormwater</u> - Roux Kritzinger -

Extensive work was done down Gulley Road through Boundary to Freda and along Jally Road to Peter Road. Drains were made next to the roads, and cleaned where blocked. Pavements were cleared of vegetation. The pipe taking water from the main beach parking area to the sea was cleaned. The drains down Elizabeth, George and Buffels Roads were opened, cleaned and routed away from Buffels Road. Many run-off channels were installed at road

junctions on the mountain roads to take water off the roads.

The one-metre pipeline from Boundary Road down False Bay Road was installed and has greatly reduced erosion. As requested, several traffic calmers were installed and a number of waterlogged roads were provided with drains to take the water away. A new channel was dug along Diana Road, from Lawrence to the Stream Road furrow, which has also reduced the erosion.

# <u>1.6 Refuse</u> - Roux Kritzinger -

The igloos in the CBD have been cleaned up and are better managed than in the past. Restaurants have greatly assisted in depositing bottles and cardboard boxes inside these bins. The trailer is more regularly serviced by the Municipality, but illegal depositing of builders' rubble, car parts, redundant washing machines, etc. remains problematic. This is the entrance to our village and does not create a good impression in its present state.

# 1.7 Community Watch (CW)

#### - Pat Dewil -

After a few well-attended meetings, the CW has been set up with Zone Managers in all but one zone. Some of these have appointed assistants to help them communicate with their neighbours and act as extra 'eyes and ears'. The system seems to be working quite well. The (rare) incidences of crime are reported immediately, but most importantly, hopefully we now have a structure that will alert residents when anything untoward occurs in the village. The baboon earlywarning system via whistles is running more effectively and we are starting to identify those properties where black bags are being left on pavements on Mondays.

A comprehensive contact list is being maintained and it is now easy to get in touch with most residents in the village. However, the CW organizers are also very aware of the need to respect people's privacy and therefore contact is only made when essential. Where appropriate, feedback from the weekly meeting with SAPS which reports on crime in our area, is fed back to the Zone Managers.

## 1.8 Security Camera **Project** - Pat Dewil -

Although not much progress is visible to the average Pringle Bayer, the project is making good progress and much behindthe-scene activity is taking place to process the approval of plans for our structure at the village entrance. Initially it was expected that this would be a mere formality but the process has since been held up by some legal technicalities. However, those concerned with this initiative at the Municipality are supportive and we are confident that the plans will be passed.

A major stumbling block has been the surprising lack of funds. Initially many verbal commitments were enthusiastically made regarding the raising of the approximately R180,000 required and although the smaller contributors have been wonderful with their donations and pledges, it is disappointing that those individuals and organisations in a position to make substantial donations. have not yet done so.

Various efforts are being made to continue to solicit donations and a very successful function was held in the Community Hall, which raised R31,371.30 for this very worthy project. As soon as the building plans have been passed, a start will be made to the entrance structure so that residents can follow its progress, despite the shortfall of funds.:

## 1.9 Community **Policing Forum** - Pat Dewil -

Our regular attendance of the monthly meeting ensures that the village is in regular contact with SAPS and has upto-date information regarding the prevalence of crime and SAPS priorities. A special note should be made of how fortunate we are to have Axel Maier in our village and the regular and very 'visible policing' in a SAPS vehicle that he is able to do. Our neighbouring villages do not have this same high policing profile.

## 1.10 The Pringle Bay **Community Hall** - Rina Scholtz -

This Committee is responsible for the management and activities of the Community Hall. Members of the Ladies' Club, Ratepayers' Committee and members of the Chamber of Commerce are represented on this Committee. The hiring of the Hall is also handled by this group. All proceeds from such activities are used to cover such costs as electricity and maintenance. The decision has been taken to enlarge the Car Park area next year and

also to create an outdoor braai facility.

# 1.11 Fire Wise - Clayton Francis -

This has been a good year for the fire-fighting team; much has been achieved despite continuing areas of frustration, the greatest of which is the attempt to purchase a 4x4 firetruck and the construction of a sufficiently large shelter for such a vehicle. To this end, plans have already been drawn up, ready for the goahead.

The firefighting team has ongoing responsibilities and meets once a month for specialized training.

The Station has been painted and a new noticeboard erected indicating: PRINGLE BAY VOLUNTEER COMMUNITY FIRE FIGHTERS. We have also designed a Pringle Bay identity badge for the left shoulder of our firefighting gear. This initiative has also been adopted by the Betty's Bay unit and it establishes the identity of the fire-fighting teams in action.

Because Pringle Bay is so heavily vegetated and therefore a serious firehazard, there is an enormous responsibility to make its inhabitants "fire-wise". The clearing of plots and eradication of Rooikrans trees and other alien vegetation is an urgent and ongoing exercise. This year there were only nine emergency incidents, and the reason for this low number is due largely to the large-scale clearing of

plots by the Fire-wise Committee and the firefighters group. Incidents this year also included: braai coals not properly extinguished, Eskom transformer complications, electrical circuit shorting and an internal house-fire.

It goes without saying that the search for future and younger fire-fighters to take over is ongoing. A team of five is essential, and prospective members need to be trained. The 64 firehydrants in the town are maintained by the fire-fighters' team. There is an application in for more of these.

A fire-wise booklet is being prepared for distribution and fire-prevention signs are being erected to create greater awareness.

# 1.12 Smallholdings - Ian Cushny -

The zoning regulations specify the use of smallholdings and the number of houses that are permitted. Subdivisions are not permitted. Currently there is a High Court case underway in respect of one of the Hangklip smallholdings regarding proposed additional houses on the property. The Overstrand Municipality is currently considering the question of additional housing and the final decision is pending.

The smallholdings in the Hangklip area and in particular those with a coastal frontage are often seen by owners and developers as being ideal for housing development and it is important that the PBRA or

# 1.13 Nature Reserves - Ian Cushny -

Pringle Bay has a number of Municipal owned large pieces of land that have been declared municipal registered Nature Reserves. The remaining smaller pieces (road reserves, etc.) are merely zoned as Open Space 111.

The registration of nature reserves by the Municipality is pressed in order to secure these reserves from development.

Efforts have been made to have a number of the Open Space 111 areas consolidated and registered as Municipal nature reserves. So far we have not been successful, but the matter will be pursued.

# 1.14 ConservancyBernard Heydenrych -

In March, we decided on 3 projects that would make up the Conservancy's objectives for the rest of the year. They were

- The development of Pringle Bay's footpaths and the printing of brochures for these paths.
- 2) The design and realisation of a small Conservancy Information Centre in Pringle Bay to provide general related information to all residents and visitors.
- The development of a miniature botanical style garden at the Pringle Bay

Community Hall, and incorporating this with the current garden area at the entrance as well as the Jenny Berrisford design. The CBD gardens were also included in this objective.

Since no funds were available at the time for these projects we made it our main objective to organise a fundraiser event to realise these. The decision was made in April to have a Pringle Bay Conservancy Day and Saturday, 11th September, was decided on. Besides the fundraising objective it was also decided that the festival should be a tool for the Conservancy to inform all residents, businesses and visitors of the mission and objectives of the Conservancy. The festival would therefore be a Conservancy related event and the majority of the stalls and exhibitors should be nurseries or other garden related products. The event would also include the TruCape Kogelberg Mountain Challenge as well as a spitbraai.

The event was a huge success with almost 1500 people attending the one day festival. People felt that the success was due to the combination of a conservation-related event with a fitness-related sporting event, as well as good entertainment and an enclosed food and wine area. One hundred and eighty eight meals were sold on the day and currently approximately R36 000.00 has been raised through this event. It was

however decided after the event that the funds raised would go towards the Pringle Bay Security project.

Plans for a 2011 event will offer a two- or three-day schedule including a mountain bike event within the festival. It is also our objective to involve the Pringle Bay CBD in next year's plans.

The Conservancy also in 2010 organised a very successful Boland Leopard Project event at the Community Hall which 128 guests attended, 101 of which had dinner. The Ladies' Club, as with the Conservancy Festival, attended to the food and yet again it was a huge success. News that the Leopard Trust intend to erect approximately 60 cameras for this project was welcomed and left the residents speculating on where the first leopard would be spotted. The Pringle Bay Conservancy also received funding to acquire a camera of its own that would be erected on the Hangklip Mountain. The Conservancy would own all images collected from this camera and plan to use this for advertising and fundraising initiatives. (See page 11)

I attended several Ratepayers, Ward as well as other related meetings this year and was surprised that the local Conservancy played such a minor role in marketing and promoting our beautiful area. Related issues seem to take a back seat at these meetings and input and advice were not widely received. This needs to change since our fauna and flora is the area's greatest asset and all residents and visitors should be given the

The Conservancy group is planning several fun events for young and old during the December holidays. Events include weekly mountain hikes, a beach day (which will include a sandcastle competition, kite flying lessons as well as educational events for the kids), several

opportunity to enjoy it.

educational events held by Mr Bruce Copley such as the Original Fire where groups are taught the ancient methods of making fire. A beach clean-up and other street and hall events are also planned by both the Ladies' Club, Conservancy and Ratepayers' Association.:

# 1.15 Environmental Affairs - Mervyn Gray Baboons:

In recent months the Environmental portfolio has been dominated by concerns over the baboon problem, which persists and raises blood pressures at every turn. Recent events have moved this issue to a higher gear: Firstly, the closed meeting of prominent members of the Pringle Bay community, which was addressed by Jenny Trethowan, founder of Baboon Matters on the Peninsula. Jenny presented a good picture of similar problems in other parts of the South Western Cape, and left those present to form their own opinions as to how we should go about solving our local problem.

The model she used was Simonstown, where they had come a long way to establishing the built-up area as no-go zones for baboons. Various methods were adopted, most significantly, the introduction of monitors who patrolled the set imaginary boundaries and chased baboons out when they made moves to enter. Nevertheless, it was established that such employment was expensive and would take up a considerable portion of the annual budget. It was clear from all this that basic rules could be observed that would alleviate the problem

Pamphlets, sign-boards and circulars were developed to encourage locals to persue the same paths. This is a long-term operation which will improve gradually as everyone understands the need to work together.

It is clear to all who walk our beautiful beach, that much of the plastic debris from across the Bay is washed up on these shores, where it remains forever until it is collected. It is an on-going battle to keep the beach cleared of this indestructible rubbish. We are grateful for the efforts of our Municipality in this regard, but there are restraints with regard to the motivation of workers entrusted with this responsibility. We are committed to shoulder some of this burden ourselves. Unfortunately it seems that the Municipality is struggling to maintain this service, which increases our responsibility.

On our national Beach Clean-up Day, a very promising group of local residents turned up and spent a couple of hours to clean up a large amount of rubbish, plastic and otherwise. This was an exercise that we should have no hesitation in supporting from time to time. It was well-attended by children from our local school, who were very enthusiastic to collect as much as possible to win the prizes. Surely, they were exposed to a good lesson about preserving our environment at the same time. It is quite sobering to see how much can be done in just over an hour when everyone works together. Maintenance of pathways

to the beach is also part of this portfolio, and my impression, after a relatively short time on this Committee, is that as soon as pathways are established and demarcated, they are covered over by sand. At best we will endeavour to set in place some beacons that will keep people on roughly the correct tracks. We should all be aware of the need to stop beach-users to walk all over the dunes and spoil this environmental reserve.

Management of dunes: This portfolio includes some supervision regarding

the activity of the dunes. Environmentally, this is a hugely sensitive area. It does not take much to be reminded of the highly controversial manipulation of the dunes some years ago. The moving dunes are certainly a threat to the dwellings of some of our ratepayers, many of whose circumstances have been considerably altered by the movement of sand. They are justifiably concerned that this could become uncontrollable as it has in other stretches of this coastline. Interference with the natural movement of dunes must be closely monitored and sensitively approached. However delicate this situation may be, it is the responsibility of this Committee to mediate when necessary, hopefully in the best interests of the home owners.

application by the Boat Club to take control of the slipway on certain (onerous) conditions. A single appeal was lodged and notwithstanding several meetings with the appellant to allay his fears and address his concerns, he was not persuaded and the appeal will now be adjudicated by the relevant authority.

The recent announcement pertaining to the limitations placed on recreational cray-fishing may well have the last say in the matter as the Boat Club was expected to provide an almost permanent presence and control over the facility. Mr Engelke, the driving force behind the initiative, informed us telephonically that he was reconsidering the entire application

since the limited use envisaged would not warrant th onerous conditions imposed and the ensuing costs. However, the appeal is to be dealt with first. Whether the Boat Club will pursue the application for adjudication of the appeal remains to be seen and cannot be predicted at this stage

## 1.17 Aesthetics, Building Regulations and **Township Development** - Honor Breyer Menke -

This year one of the focus issues has been on the finalization of the proposal initiated by Clr. Louis van Heerden for local building requirements to supplement those contained in the National Building Regulations. This is a fairly lengthy document which was submitted in November by Clr. van Heerden to the Council for approval.

During the year there have The authorities approved the been several Environmental Impact Assessments carried out prior to development on sensitive sites. As interested and affected parties, we have had the opportunity to voice any concerns brought to our attention. The Department of **Environmental Affairs is** currently assessing the impact of transgressions committed by two property owners and final resolutions are awaited.

There have been a few investigations regarding owners who have ignored or might have ignored building line restrictions and two of these have been referred to Province where a decision could take between 1 and 2 vears.

Matters of general concern to property owners such as poorly maintained sites and incomplete buildings were frequently brought to our attention and these were referred to Building Control or Law Enforcement.

A public parking issue is in the process of being resolved and a concern regarding subdivision and/or change of use with reference to the Pringle Bay Structure Plan has been addressed.

The presentation of the Stormwater Master Plan raised the question of its potential harmful effect on the fynbos and Cape Nature has appointed a hydrologist to investigate.

# **OTHER ISSUES** 2.1 R44 Trunk Road

In view of the planned tolling of the N2, the residents of the four communities from Rooi Els to Kleinmond were concerned about the impact of an increase in traffic. Safety on the R44 from Gordon's Bay to the junction at the R43 will be problematic. The general feeling was that a substantial

volume will divert to the R44 to avoid toll costs. Special attention must be given to the following:

- · Impact of large trucks, e.g. interlinks.
- Possible danger spots along the road.
- The impact of higher volumes of traffic on towns like Betty's Bay and Kleinmond.
- Ways and means to address these concerns.

Jan Willem van Staden, Chairperson of the Federation of Ratepayers, compiled a very detailed report on the problems related to the R44 – this report is available from the Chairperson.

## 2.2 Arabella Phase 2

The matter of Arabella 2 has been raised at various levels. In the course of meetings this year, the PBRA has discussed the various issues relating to this with a view to taking a stand where it looks to be having a detrimental effect on the community and the environment. Such issues as: excessive demands on boreholes in the area; the influx of workers, drawn to

possible employment and this effect on local workers; the pressure on local facilities of an increased demand for accommodation already under considerable strain; the inappropriate visual impact of the new buildings on the north side of the R44, and the unfortunate precedent which may be set by allowing such a building project to ignore the restrictions of the buffer zone. The committee has decided therefore to allow time for more detailed and professional advice to reach it before any decisions are taken on further action.

#### CONCLUSION

2011 will bring its own new challenges and problems, but I truly believe that the PBRA is in good shape to meet them. On behalf of the members of EXCO, I wish you and all your loved ones a merry Christmas and a prosperous New Year.

May 2011 bring blessings and great joy to all who live in Pringle Bay.

# ARE THERE REALLY LEOPARDS AROUND PRINGLE BAY?





An extremely well organized evening which was attended by what was probably the biggest turnout in Pringle Bay history was held recently in the Community Hall to hear a presentation from the Cape Leopard Trust. This organization was established "to

For many years there have been rumours and stories about leopards being seen in and around Pringle Bay.

In fact, there have been a few reported sightings, both on the outskirts of the village and even one notorious incident some years back when a local resident who had small-holding across the R44, shot a leopard which he alleged was threatening his sheep. The resulting uproar from as far away as the US firmly established that people generally are on the leopard's sidel

So - how many leopards are there? Where do they hang

The current work of the Trust includes several research projects involving leopards in the Cape and elsewhere in South Africa, including a comprehensive conservation genetics project estimating gene flow, genetic variability South African leopard populations. So, you may ask, "why the leopard".

The Leopard Trust explains "The leopard fills the role of the apex predator in the Western Cape ecosystem and acts as an "umbrella species" which will effectively help in the conservation of smaller, lower profile predators. Its resilience to persecution notwithstanding, the leopard has suffered extensive range loss in the Cape and is now extinct in many areas of the province where it formerly occurred. The species is removals are sustainable or

to conflict are established".


So the result of all of this is that the Trust plans to set up a number of cameras in our area to get an understanding of just how many leopards there may be in our back yard and what their movements are. These cameras are triggered by movement and will be monitored on a regular basis.

From this, they may decide to collar some of 'our' leopards to monitor their movements and behavioural patterns.

This could provide some very interesting information and as things develop, we will publish the details.

# DO WE HAVE ANY LEOPARD **TOADS LEFT IN PRINGLE BAY?**



According to the IUCN Red List of Threatened Species, subpopulations of the leopard toad in Kleinmond, Betty's Bay and Pringle Bay are now thought to be extinct.

However, according to the Facebook page, The Endangered Western Leopard Toad, three new breeding sites were found in the Overstrand area, resulting in a new total of seven known sites in the area.

The Leopard toad (Amietophrynus pantherinus) is described as an endangered amphibian. They are found in the southern reaches of Cape Town with known breeding sites ranging from Observatory to Glencairn. Another outlying www.leopardtoad.co.za population is found at scattered sites on the east coast running from Pringle Bay to Stanford.

The toads have chocolate brown markings on a bright yellow background with redbrown parotid glands on their foreheads. In older individuals the general appearance turns darker and the colours are duller and less pronounced, while toadlets have vivid parotid glands to ward off predators.

Due to numerous factors, such as a small world locality, a restricted distribution range, habitat loss and the current

most significant threat, urbanisation, the leopard toad is under serious risk from numerous angles!

The toad breeds in and around the month of August, which is typically around the time of the arrival of the first post-winter warm weather. Living in urban gardens, the toads (which are nocturnal) migrate across unpredictable terrain and over roads to reach scattered breeding ponds. They are at their most vulnerable when crossing roads.

Over the last decades, the great loss of migrating toads has lead to an extreme decline in numbers and populations, with a fast decline in overall species numbers.

# THE TRUTH ABOUT ARUM LILY FROGS



Recently an emailmade the rounds warning people about the sale of Arum lilies and the possible extinction of two Cape frogs: the Arum lily frog and the Micro frog. The email warned people not to purchase arum lilies from vendors at the side of the road as this could lead to these two species being wiped out.

However, the **Environmental Management** (ERM) Department, in conjunction with CapeNature and the South African National Biodiversity Institute released a statement including the following: While the arum lily frog



on them. breed in wetlands and not in the flowers of the arums. The micro frog is ground-dwelling, breeding in temporary pools, and it does not climb into any

However, arum lily frogs are very pale and they hide their bright orange feet and legs under their bodies during the day. In this way, the frog is able to use a white background as camouflage against predators and this background is sometimes the white arum flower. They do not use the pollen of the flowers to camouflage themselves, as has been

While arum lily frogs are only found in the Western Cape (and a small area of the Eastern Cape), they are not classified as threatened in the 2004 Red Data book. However, it is true that the species is becoming increasingly rare as their habitat is lost to urban development.



- ∡ Arrange with reliable neighbours for reciprocal surveillance when away from home for any length of time;
- Leave lights on when away somewhere at night. As our areas do not have street lights we need to take special precautions as criminal elements are easily able to remain concealed;
- Ensure that residences are easily approachable and free from concealed means such as shrubbery and trees;
- ∡ A watch dog is a good early warning system especially if kept close to the owner or inside the house;
- ∡ Be familiar with your environment. Be constantly on the look-out for suspicious looking characters or vehicles and do not hesitate to report them to the SAPS:
- ✓ Ensure that Erf numbers are clearly and prominently displayed for emergency purposes;
- ✓ Ensure that all windows can be properly locked and are burglar proofed;
- ✓ Ensure that exterior doors are fitted with adequate locks;
- ✓ Never leave door keys hanging in the door;
- ✓ Don't leave spare keys lying around in your house. Place them in a safe place;
- Firearm owners must ensure that their firearms are kept safe at all times. Firearms must always be under your direct control or locked away in a firearm safe;

- ✓ in a firearm safe:
- ✓ Never leave ladders, axes and spades outside. These are potential housebreaking tools and weapons;
- ∡ Ensure that an intruder detection system is connected directly to a security company providing a 24 hour service. Ensure that the system is always activated when away from home;
- make sure that your cellphone is concealed. Never leave cellphones lying on a seat in the car
- strangers, perhaps disguised as workmen or vendors, who may be loitering in the neighbourhood. Also be aware of job seekers;
- ✓ Look out for suspicious vehicles that cruise the area at intervals and who may be keeping houses under observation. People and/or vehicles giving rise to suspicion should be reported to the SAPS, along with the fullest possible personal and vehicle descriptions;
- ✓ Ensure that front and back doors are not left open or unlocked;
- ✓ Keep garage doors closed and locked;
- not left on seats in cars parked at unprotected and isolated areas. Rather keep them locked away in the boot;
- ✓ Never leave car keys in the ignition when away from the
- ✓ Keep a list of the make, model and serial numbers of electrical appliances and other valuable equipment should it be required for investigation purposes.



# **Important Information**

#### Fires!

When the wind blows (which is nearly every day) the probability of fire increases dramatically. NEVER make a fire when the wind is very strong and please NEVER leave it unattended. Only use designated braai areas and NEVER make a fire on the beach. Flying sparks have been known to set fire to the fynbos with devastating effects. Fires MUST be put out with both sand and water as exposed coals can be re-ignited by the wind.

#### **Dunes**

Our shifting dunes are in trouble. Houses have blocked the path of the north-wester, which used to return them to their place of origin. We are currently

doing our level best to stabilise the dunes so please keep to the footpaths and do not make new ones—tempting as it is when the beach is just on the other side!

Fynbos
Without a permit you may only feast your eyes on the magnificent biodiversity that surrounds us. Please, do not pick or remove plants and please be careful where you walk to avoid trampling on seedling.

Wildlife

There is a R500 fine for feeding baboons. Close windows on leaving your house, and if your home is in a baboon frequented area, keep an eye peeled for visitors! If a baboon drops in, do not get between the animal and its line of exit. Banging on something loudly, e.g. a spoon on a pan, may encourage an exit.

Marine Life
Permits for fishing, crayfishing and for collecting mussels and other sea life may be obtained at the Post Office. Please do your bit to keep our pristine beaches clear of litter and fisherman's debris. Report poaching activities and people overstepping bag limits to Seawatch —082 994 9300.

**Pets** 

Unleashed and unruly dogs cause havoc with the wildlife whether you are walking on the beach, taking a country stroll or fishing. Dog owners, please carry a poo-bag with you and clean up after your dog. Please ensure that your dogs have ID tags and cannot wander off your property, day or night.

**Light Pollution** 

Any lights shining beyond the perimeter of your property is prohibited by law. Please, put on outside lights only when absolutely necessary and do not leave them on at night. Besides destroying the night sky visual, lights also destroy the natural biorhythms of both flora and fauna.

Refuse

New legislation says that bags may not be left on the side of the road, or put out in advance, as this is an open invitation to a baboon invasion as well as dogs and ibis. Place bags in a secure and baboon-proof bin situated inside your property boundary. If you miss collection, bags must be placed in the trailer at the entrance of town.

Blus brande met sowel water as sand, want die wind kan blootgestelde kole weer laat opvlam.

#### Duine

Ons waaisandduine is in gevaar. Huise sper die noord-weste wind af, wat die duine altyd teruggeskuif het. Ons doen tans ons bes om die duine te stabiliseer. Gebruik dus asseblief net bestaande voetpaadjies en moenie nuwes skep nie, al is die strand net aan die ander kant!

# **Fynbos**

Sonder 'n permit mag jy die pragtige biodiversiteit om ons net met jou oë bewonder. Moet plante asseblief nie pluk of verwyder nie, en kyk mooi waar jy loop, sodat jy nie saailinge plat trap nie.

#### Wild

Daar is 'n boete van R500 as jy bobbejane voer. Maak vensters toe as jy nie in die huis is nie, en hou dop vir harige besoekers as die omgewing 'n gereelde bobbejaan-kuierplek is. Sorg dat jy nie tussen 'n bobbejaan in die huis en sy ontsnaproete staan nie. As jy hard op iets slaan, byvoorbeeld met 'n lepel op 'n pan, sal die bobbejaan waarskynlik die wyk neem.

#### Seelewe

Kry permitte vir hengel, kreefduik, mosselpluk of die vergaar van enige ander seelewe by die Poskantoor. Help asseblief om ons strande van rommel en hengelafval skoon te hou. Meld stropers en mense wat meer uithaal as wat hulle mag by Seawatch aan (082 994 9300).

#### Troeteldiere

Losloper- en onbeheerde honde saai verwoesting onder ons wild, ongeag of jy op die strand stap, deur die fynbos wandel of vis vang. Neem 'n landmyn-sak saam. Sluit honde asseblief ook snags toe.

#### Ligbesoedeling

Geen regstreekse lig mag kragtens die wet buite jou eiendomsgrense skyn nie. Skakel buiteligte asseblief net aan as dit absoluut nodig is, en skakel snags af. Ligte verdof nie net die prag van die naghemel nie, maar beïnvloed ook die natuurlike bioritmes van sowel diere as plante.

#### Vullis

Volgens wetgewing mag sakke nie langs strate gelaat word nie, want dit lok bobbejane, sowel as honde en Skoorsteenveer-voels. Sakke mag nie vooraf uit gesit word nie. Plaas sakke in 'n veilige bobbejaanbestande houer binne die grense van die eiendom. Gebruik die vulliswa by die ingang van die dorp indien jy versameldag gemis het.


